4. APPROVAL OF MINUTES:

The minutes from the April 9^{th,} 2025, meeting were reviewed.

8. STAFF REPORTS:

Carol Madison made the following report:

-Our site review for the Child Care programs went well. We need to complete a Continuous Improvement Plan and submit it to the state by June 5th, 2025. We will also be completely rewriting our Parent and Provider Handbook. The State also reviewed the CFCC Family Day Care Home Network contract that is currently held by the County Office of Education and subcontracted to TEACH. The County is relinquishing that contract, and we will be applying for it. Rocio Campos and Katelyn Schoenauer will be attending contract training in June.

- -Noelle and I met with the Board Chair, Executive Director, and staff of the Modoc Work Activity Center. They would like to turn their entire program and all of their assets over to TEACH. The alternative to our taking over the operations is the shutdown of the facility. That would be detrimental to the community and leave families without services. We would have to get licensed by Community Care Licensing as an Adult Day Care Center. I've reviewed their tax returns and financial statements. Their revenue is approximately \$360,000.00, and their assets are valued at \$480,000. They are financially viable. I also think that there's a lot of room for growth.
- -VALOR US, the sexual assault service providers' association, sent out an email on April 23rd stating that multiple Office for Victims of Crime and Office of Justice Programs were cut by the federal government. They facilitated a webinar with an attorney to inform agencies of their rights if their grant was cut and provided information on what non-profits should do if the IRS tried to remove their 501(c)3 status by designating the non-profit as a "Terrorist Organization." A few days later, VALOR sent out another email informing the agency that it wasn't our funding that was being cut.
- -Nikki Kates and I met with the Modoc County Department of Social Services to discuss the transfer of two more housing contracts to TEACH. The transfer will be effective July 1, 2025.
- -Noelle and Tia Sekavec will be attending a week-long training in Austin, TX, on our Accounting System.
- -I would like the board's opinion on offering paid time to employees to volunteer at the schools or other acceptable organizations.
- -We were selected by Heather Hadwick as Non-Profit of the Year for her district. I will be attending a luncheon in Sacramento next week to accept the award.
- -We would like to either have the next board meeting at the Wellness Center or tour the Wellness before or after the meeting.

Member Yarberry made the following report:

- I will be leaving my position at MCOE and taking on more of a role at Advancing Modoc. I will be stepping down from the board by the end of the fiscal year. I am hoping to find a replacement who has knowledge of the education system. That is why I invited Sarah Stockwell to the meeting today, because I think she would be a great fit.

If an employee who is the parent or guardian of a child facing suspension from school is summoned to the school to discuss the matter, the employee should alert his or her supervisor as soon as possible before leaving work. In agreement with California Labor Code Section 230.7, no discriminatory action will be taken against an employee who takes time off for this purpose.

Recreational Activities and Programs

T.E.A.C.H. or its insurer will not be liable for payment of workers' compensation benefits for any injury that arises out of an employee's voluntary participation in any off-duty recreational, social, or athletic activity that is not part of the employee's work-related duties.

Inclement Weather/Natural Disasters

In the event of severe weather or a natural disaster that prevents employees from safely traveling to and from work, the following leave policies will apply:

- Inclement weather: Conditions that excuse absence from work include: road closure, announced avalanche danger, whiteout, heavy rain, and severe flooding. If weather conditions prevent you from safely traveling to work, you must notify your supervisor by phone, if telephone service is functional, or by any other available means. Employees may be paid, at the discretion of the Executive Director, for up to 2 days per year when severe weather conditions prevent them from reaching their worksite. Absences in excess of 2 days will be unpaid or will be deducted from accumulated vacation time.
- **Natural disasters:** In the event of a natural disaster such as earthquake, fire, or explosion, offices will be closed if the building is damaged or roads leading to the offices are damaged. For instructions on reporting to another location, contact the T.E.A.C.H., main office immediately, if possible.

Lactation Accommodation Policy

Training, Employment & Community Help Inc. recognizes lactating employees' rights to request lactation accommodation, and accommodates lactating employees by providing a reasonable amount of break time and a suitable lactation location to any employee who desires to express breast milk for their infant child, subject to any exemption allowed under applicable law.

If possible, the break time should run concurrently with your normally scheduled break time. Any break time to express breast milk that does not run concurrently with your normally scheduled break time is unpaid.

The lactation location will be private (shielded from view and free from intrusion from coworkers and the public) and located close to your work area. The location will be safe, clean and free of toxic or hazardous materials; have a surface to place a breast pump and other personal items; have a place to sit; and have access to electricity or alternative devices (such as extension cords or charging stations) allowing you to operate an electric or battery-powered breast pump. Training, Employment & Community Help Inc. will also provide access to a sink with running water and a refrigerator suitable for storing milk in close proximity to your workspace. If a refrigerator cannot be provided, Training, Employment & Community Help Inc. will provide another cooling device suitable for storing milk, such as an employer-provided cooler. The lactation location will not be a bathroom or restroom. The room or location may include an employee's private office if it otherwise meets the requirements of the lactation space. Multi-purpose rooms may be used as lactation space if they satisfy the requirements for space; however, use of the room for lactation takes priority over other uses for the time it is in use for lactation purposes.

Employees who desire lactation accommodations should contact your immediate supervisor to request accommodations. An employee's request may be provided orally, by email, or in writing, and need not be submitted on a specific form. We will engage in an interactive process with you to determine when and where lactation breaks will occur. If we cannot provide break time or a location that complies with this policy, we will provide a written response to your request.

Training, Employment & Community Help Inc. will not tolerate discrimination or retaliation against employees who exercise their rights to lactation accommodation, including those who request time to express milk at work and/or who lodge a complaint related to the right to lactation accommodation. If you believe you have been denied reasonable break time or adequate space to express milk, or have been otherwise been denied your rights related to lactation accommodation, you have the right to file a complaint with the Labor Commissioner.

NorCal CoC Administrative Entity and NorCal CoC Operations Overview

Overview

NorCal CoC Executive Board, decision-making body, contracts for operations through MOU with Administrative Entity. Administrative Entity enters into contracts on behalf of the NorCal CoC for service administration and grant distribution.

Between 2021 and April 2025 the NorCal CoC has applied for and received over \$15,700,000 in state HHAP funding to distribute to the seven counties and seven CoC Advisory Boards in the NorCal CoC. NorCal CoC EB has contracted with Housing Tools to assist with preparing the HHAP 6 application for a total \$5,806,452 in HHAP 6 funding.

Additionally the NorCal CoC has applied for \$440,000 in annual FY 2024 HUD funding for HMIS, Coordinated Entry, Planning and Housing Partners II grants. Historically HUD funding has been approximately \$450,000 per year. Per HUD regulations CoC's are required to provide Homeless Management Information System (HMIS) and Coordinated Entry System (CE). (CE is a centralized or coordinated process developed to coordinate program participant intake, assessment, and referrals.)

The previous two year budget was fully funded, including a contingency, with primarily state HHAP flexible grant funding and some HUD funding. The seven counties and seven CoC entities contributed eligible system support HHAP 3, 4, and 5 grant funds toward NorCal CoC administration expenses on a percentage basis. The CoR and UWNC were the only entities to accept the administration roles and the NorCal CoC EB committed to prevent any encroachment on the CoR general fund and UWNC general operation funding. To date no other entity has indicated an interest in serving as the Administrative Entity. The funding of a future proposed budget and any unanticipated expenses would be distributed among the NorCal CoC members.

 - iv. Enter new contract for Independent Contractor to provide AE Executive
 - v. Enter new contract with Teddie Pierce for services for policy development, HUD and State application assistance
 - vi. Hire or enter into contract for Management Analyst for grant AE contract admin
 - vii. Assume existing HHAP 3 and 4 grant contracts, possibly some HHAP 5 contracts (see list of HHAP contracts)
 - viii. Assume existing contracts to receive HUD funds and contracts to provide the HUD match or enter into new contracts depending on period of performance, HUD Planning grant and match funds for HMIS, CE and Housing Partners II. (List of HUD grant awards to be sent under separate cover.)
- C. Determine costs and roles and responsibilities for Non-Profit Admin Operations
- D. Determine costs to create website to post NorCal CoC info, including agendas and minutes, PIT & HIC, grant NOFAs and annual notifications. Estimated to take 63 hours annually to provide website updates and maintenance.

E. HMIS/CE

Assume or enter into contract on behalf of NorCal CoC with HMIS/CE Administration beginning 9/19/25. Could include preparation of RFP for HMIS/CE Administration for period beginning 9/19/25 or 12/31/25.

4. Proposed Short-term goals (1-3 mo)

Create budget and align funding sources

Evaluate options to revise structure of NorCal CoC

Improve system of care, delivery of services to those in need
