#### 1. Call to Order

A meeting of the Shasta Advisory Board was called to order at 3:01 p.m. by Chair Maggie Joyce. A reminder of the Brown Act was completed.

#### 2. Introductions/Establish Quorum

Quorum was established, and the meeting was called to order.

## 3. Approval Meeting Minutes

Lesha Schaefer motioned to approve the meeting minutes of November 14, 2023. Kristen Schreder seconded the motion. All in favor.

## 4. Public Comments

Amber Middleton discussed a new mobile HOPE van that replaces their current van. A press release will be going out soon to the Community. She also discussed that they received documents for certification for the medical program.

Justin Wandro announced the Homeless Memorial will take place on Wednesday, December 20, 2023 @ 11 am. Located at 3075 Veda St. Redding, CA. They will be honoring the memory of 40 who passed away while experiencing homelessness and bringing awareness, they have names for 23 out of the 40.

Susan Weiss commented on the At Home Plan, she wrote Barry Tippin her input and encouraged the rest of the group to send input to Barry, along with attending the December 19, 2023, City Council meeting. She also stated that everyone should watch the previous City Council meeting online to hear the discussion. She shared her thoughts that Housing 1<sup>st</sup> is most important, but it was put last, and why was the jail even there.

Nicole Smith announced there will be an At Home Public Meeting at City Hall in the Caldwell Park room on Thursday, December 14, 2023.

Megan Preller announced Ready for Life Host Homes Resource Center was hosting an Open House on Monday, December 18, 2023, for homeless youth 18-24, come shop for clothes and enjoy hot cocoa and snacks.

#### 5. New Business

#### Action:

A. 2024 Monthly Meeting Calendar

Kristen Schreder motioned to approve the calendar, Megan Preller seconded the motion, and all approved it.

#### B. Membership Applications

- a. Robin Bostain-HHSA Kristen Schreder made the motion to approve the calendar, Lesha Schaffer seconded the motion, and all approved it.
- b. Michael McNair-Access Homes and Brent Eddy made the motion to approve the calendar, Rachel Alvey seconded the motion, and all approved it.

#### Discussion:

#### A. Attendance/Membership Representation

Maggie Joyce reminded the group that if a voting member cannot attend, they send their alternate. It is very important to meet quorum. Kristen Schreder asked the group if everyone was good with who was listed as a member and alternate and if everyone was getting emails. It was stated that alternates do not get the emails but should. It was agreed to add the alternates to the email string. Voting members need to send contact information to Maggie and Kristen.

# B. Status of Funding: HHAP, HHIP, ESG, Collaborative Application & Housing Partners II

Kristen Schreder pointed out Attachment 5 was created so that the group could have it in writing to the status and updates to funding and would be a working document with timelines.

HHAP5- Met with Housing Tools, the consultant. They will provide a proposal in a couple of days, which will be discussed at the Executive Board meeting on December 21, 2023. This round will need an additional Regional Homeless Plan for all 7 counties, each county must get into an MOU.

HHAP4- The City of Redding is still waiting for the check from the State.

HHAP3- The state is still waiting on more information from the County to be able to complete the amendments to the contracts with the City for transfer. The county will have 90 days from execution to transfer funding to the City. Since they have not received money, Lesha Schaffer asked about the expenditure timeline, but deadlines remain the same. Confirmed that money

needs to be obligated, and expenditures made after the 7/1/22 (date included in HHAP 3 state contract) can be included in the HHAP 3 project expenditures.

HHAP1&2- There is an agreement between the State, City, and County on the balances, and the contract are executed, and the County has 90 days from December 6, 2023, to transfer funding.

HHIP- Back to City Council on December 19, 2023, for approval for remaining applications.

Collaborative Application- Working on Planning agreements and other contracts.

Partners II- The City will release an RFP to find a new provider for the project.

#### C. HMIS Transition

a. License Agreement- Still on track for United Way to take over on January 1, 2024, working with County staff and HUD to cover all requirements. They are still waiting for paperwork to be signed by the County to work officially with WellSky, but they have a workaround for now. End User agreements will go out soon, no one services will be turned off, Cyber Insurance is being discussed, and HHIP funding will pay for all Licenses for users.

Reports due in January- LSA and PIT/HIC

b. HMIS Committee- The last meeting was canceled, and the next is in January. Everyone should delete all old calendar invites; Tim Danielson will send out a new invite for HMIS/CES meetings.

## D. PIT/HIC Planning 2024

The Simtech contract is just awaiting Barry's signature. There needs to be an ad hoc/committee to prepare the Simtech app and how the HIC/shelter count will happen. The group needs direction on completing the HIC count, as it was the Lead Agency role prior. Megan Preller gave an update on the PIT committee at this time since it was pertinent to the discussion. Her recommendation was that Shasta make decisions on forms, methodology, and feedback for the committee since Shasta has more areas than the rest of them, and it would make it easier for the committee. Tim Danielson will work with Paul at County for the HIC list.

Amber Middleton asked about Threshold Requirements for funding since one of the requirements is to be a part of PIT, and since there is not a full count this year, how should the group precede?

Decided that the January 9, 2024, Advisory Board meeting will be about the PIT, which will give all members the opportunity to participate.

Kristen Schreder asked if anyone could volunteer to help Dawn Pittore with the Simtech App. Rachel Alvey volunteered.

# 6. Reports

#### A. Executive Board

Kristen Schreder stated that there is nothing new at this time other than what was discussed already.

# B. County/City

Nicole Smith stated the City received 2 Encampment Grants that will need to go back to the

City Council for final approval on projects. Projects that are being worked on for possible funding are Clean up, Remodel of GNRM, Sanitation Support, CIRT funding, Case Management, Emergency Shelter, and Resource Day Center.

Lowden Lane Senior Housing and Kennett Senior are finishing up and will be leasing up soon. Piper Way Senior Housing broke ground.

CoC Associate Project Coordinator is set to start on January 2, 2024.

Emily Kerr stated that the county is working through all the transitions and also on some new development projects.

#### C. PIT Committee

Megan Preller Shelter counts to occur on the night of January 23, 2024. They also voted in the survey using the requirement questions to save time.

## D. Landlord Engagement-

Hillary stated the 1<sup>st</sup> luncheon was a success, and they plan to do them quarterly. The need is for more landlords/owners to attend. Discussed Landlord Incentives from County and Nation's Finest Case Management provided to Vets are good talking points for anyone that knows owners/landlords that would be willing to work with them. Hillary also stated that the PIT count for Vets needs to be reviewed better as they are finding many who are not Vets. She announced that this will be her last CoC meeting as the VA only has 2 Case managers at this time.

Kristen Schreder announced the next CoC Executive Board meeting will be held at the Enterprise room at City Hall.
