HHAP-5 Overview

- The Homeless Housing Assistance and Prevention (HHAP) Round 5 Notice of Funding Availability (NOFA) was published Sept 29, 2023.
- Eligible applicants are the 44 Continuums of Care, 58 counties, and 14 large cities with populations over 300,000.
- This grant program provides local jurisdictions with flexible funding to continue efforts to improve regional and systems coordination to prevent and end homelessness in their communities.
- ❖HHAP-5 requires three public meetings, a Regionally Coordinated Homelessness Action Plan (Plan), a Memorandum of Understanding (MOU), and a Funding Plan or Plans (if counties apply to administer their own funds with the State)

Format

- ❖ Cal ICH (California Interagency Council on Homelessness) has provided a template which constitutes the HHAP-5 Plan/Application.
- It consists of a series of tables that focus on both quantitative and qualitative data.
- The NorCal CoC Plan/Application is intended to be a joint application for the CoC and each of the seven counties. Per Cal ICH instructions, counties must apply as part of a regional application with the CoC. In a multi-county CoC, counties are strongly encouraged to apply in collaboration with other counties served by the same CoC.
- *While counties must be a signatory to the Regionally Coordinated Homelessness Action Plan, and the MOU, counties can choose to receive their County allocations directly from the State as their own Administrative Entity.

Eligible Uses

- HHAP-5 funds can be used to support activities that fall within three main buckets:
 - Permanent housing
 - Interim housing (no new Interim Housing projects unless approved by Cal ICH)
 - Service provision and systems support
- There is a required 10% youth set-aside.
- Administrative costs are capped at 7%, and Homeless Management Information System (HMIS) costs are capped at 1%.

System Performance Measures (SPMs)

- System Performance Measures (SPMs) are a series of metrics developed by Cal ICH. These metrics are used by CoCs in the HHAP Plan/Application.
- ❖The SPM data comes from the State's Homeless Data Integration System (HDIS), which processes data from the 44 CoC Homeless Management Information Systems (HMIS).
- As part of the HHAP-3 Plan/Application in 2022, the NorCal CoC region set Outcome Goals and Strategies to Achieve Outcome Goals using input from the CoC Executive Board and members. The SPM data for HHAP-5 provides insight on the progress the region has made thus far and will be used to help plan the new Key Actions.

 - National Housing Trust Fund
 - HOME Investment Partnerships Program
 - Parolee or Probation programs intended to prevent homelessness upon release

Plan to Connect People Experiencing Homelessness to All Eligible Benefit Programs

- Connection strategies for:
 - CalWORKs
 - CalFresh
 - SSI/SSP and Disability Benefits Advocacy
 - IHSS
 - Adult Protective Services
 - Child Welfare
 - Childcare
 - Medi-Cal Benefits through Managed Care Plans
 - Other
- Lead and Collaborating Entities

Round 5 Compared to Rounds 1-4

- *HHAP-5 has unique requirements compared to the previous four rounds.
 - Three public meetings
 - Regionally Coordinated Homeless Action Plan (Plan)
 - Memorandum of Understanding (MOU) that incorporates the Plan
 - The CoC and Counties are required signatories to the Plan and MOU. Cities are optional signatories
 - In order to receive supplemental disbursements of HHAP-5 funds (slated to be made available in 2026, with info published in 2025), each County must have signed onto an approved RCHAP and have a State approved and compliant Housing Element
