Lorenzo Love expressed concern about extreme heat and its impact on vulnerable populations. He urged early planning for a cooling shelter.

Luther Findley spoke about Tuesday evening dinner service. He mentioned that he is excited for the opening of Basecamp and Siskiyou Village, two new shelter projects set to begin operations in 2025. However, he noted that this will not be enough housing for the number of individuals experiencing homelessness in the community and suggested a location in Northern Yreka for a City-run urban campground.

Dawnmarie Autry agreed with Luther Findley and noted that she had previously recommended this same location to the Yreka City Council.

Maddelyn Bryan summarized the resident selection criteria for Siskiyou Village, noting that CARE Court participants will be prioritized. The remaining units will be filled via Coordinated Entry.

Mark Gilman shared some statistics on calls related to homelessness. He said that since January 2025, there have been 353 calls to the Yreka Police Department (YPD) relating to homelessness. YPD had about 200 contacts with individuals experiencing homelessness during this time frame.

4. Committee Updates

a. Executive Board Update - Maddelyn Bryan

Maddelyn Bryan noted that the NorCal Continuum of Care (CoC) is currently not showing enough progress in HMIS data metrics to qualify for the second half of the HHAP-4 funding. In response, the CoC is drafting a letter to the State to explain the unique geographic and operational challenges we face and is also developing a broader plan to address the unmet performance measures. It is uncertain whether this explanation will be enough to secure the remaining funds. The State's performance measures are interconnected, making progress more complex. Maddelyn Bryan also shared suggestions for actions the County could take to help improve outcomes. The group discussed the data being collected and the specific challenges rural counties face in meeting the required goals.

The CoC is holding monthly data performance workshops to assess our HMIS data and come up with an improvement plan. Maddelyn Bryan encouraged anyone interested in attending to email the NorCal CoC at norcalcoc@cityofredding.org.

a. Yreka Basecamp - NVCSS

Tara Kilcollins, Basecamp's shelter manager, provided the latest project updates. The City of Yreka is scheduled to conduct a site inspection tomorrow. NVCSS is still waiting on a part to complete the laundry room, and the ADA shower pan remains on backorder. To help move things along, the City will install a temporary ramp at the front entrance. Most of the hiring for the project is complete, and volunteer training will begin in late May. Later this month, Tara plans to stay overnight at a congregate shelter in Red Bluff to gain insight into their operations.

b. Integrated Shelter Plan (Attachment D) - Nancy Ogren

Nancy Oregon read excerpts from Attachment D, the Warming and Cooling Shelter Plan adopted in January of this year. Discussion ensued on transportation to these centers and the need for secure storage options for people to feel comfortable leaving their tents behind. Tara Kilcollins suggested setting up a workgroup to discuss these issues in more detail and brainstorm solutions.
