4. Discussion Items


I. Continued discussion of PIT/Coordinator position – Kristen Schreder

Kristen Schreder presented a spreadsheet with a detailed proposal for a PIT Administrator. This would be a contracted position with the City of Redding. The contract would have a total not to exceed of \$40,000/annually, funded by HHAP-4 and 5. Members discussed a timeframe of 1 year vs 2. They agreed the CoC should post an RFP before the end of May.

II. 2024 PIT/HIC status update – Tim Danielson

Tim Danielson stated that the PIT and HIC data have not been submitted due to issues with HUD's HDIX site. He noted that improvements and corrections are in process for the PIT/HIC projects which staff will have to enter into HMIS in the future.

III. Review of PIT forms and surveys



Tim Danielson shared that some of the providers had confusion over the forms. Most projects will not have to use the form again since HUD will pull the data from HMIS in the next HIC Count. Discussion ensued about asking the new PIT Administrator to update and streamline the forms. United Way staff provided a demonstration of the HDX system.
