All items presented to the Behavioral Health Board during a public hearing, including but not limited to, letters, e-mail, petitions, photos, or maps, become a permanent part of the record and must be submitted to the Behavioral Health Board, Executive Secretary. It is advised that the presenter bring 7 copies of anything presented to the Board and that the presenter create copies in advance for their own records. As a courtesy to the public, Siskiyou County offers teleconference access to the hearing, however, if no member of the Behavioral Health Board is attending the hearing via teleconference and disruption, outage, or technical error occurs, the Board reserves the right to discontinue teleconference access and to continue conducting the hearing.

All public records related to an open session item on the agenda, which are not exempt from disclosure pursuant to the California Public Records Act, that are distributed to a majority of the legislative body will be available for public inspection at 2060 Campus Drive, Red Oak Room, Yreka CA 96097 at the same time that the public records are distributed or made available to a majority of the members of the legislative body. All supporting documentation is available for public review in the office of the Executive Secretary of the Behavioral Health Board, located in the Siskiyou County Behavioral Health Executive Secretary's Office, 2060 Campus Drive, Yreka, CA 96097, during regular business hours, 8:00a.m. – 12:00p.m. and 1:00p.m. – 5:00p.m., Monday through Friday or on the County website at <https://www.siskiyoucounty.gov/behavioralhealth/page/bhsa>.
